

FSU COVID-19 Status of Mitigation Measures for Fully Vaccinated and Non-Vaccinated Individuals

The following standards shall apply to all Framingham State University grounds, facilities and operations. All students, employees, and authorized guests participating in activities on campus must comply with the requirements described below.

- **Relaxation of mitigations is allowed for fully vaccinated individuals *only*.**
- **Non-vaccinated individuals, including those with authorized exemptions, must continue to wear masks while on campus grounds or facilities and practice social distancing for their own protection and the protection of community members to reduce the spread of COVID19.**

These requirements or restrictions will be continually reviewed to respond to community public health information as well as state or federal guidance that may suggest or require alteration of these standards. Additional standards required of specific operations will also be met in accordance with state guidance and the campus requirements described below.

Individuals choosing to maintain a mask wearing practice in addition to vaccination may do so at their discretion and this personal health decision should be respected and authorized.
