



HEALTH FORMS & IMMUNIZATION REQUIREMENTS

Due July 1 for Fall Enrollment | Due January 1 for Spring Enrollment

Framingham State University requires the following students to submit health information based on Massachusetts Department of Public Health Regulations and University Policy: all fulltime graduate and undergraduate students; all students applying for housing; all International students; all health science students.

Resident students: Incomplete requirements will PREVENT YOU FROM MOVING INTO CAMPUS HOUSING.

Commuter Students: Incomplete requirements will result in a REGISTRATION HOLD that will remain in place until requirements are met.

STEP 1: LOGIN TO THE FSU STUDENT HEALTH PORTAL (MEDICAT)

- FSU Student Health Portal: <https://framingham.medicatconnect.com>
 - › Your Medicat login is the same as all other Framingham State logins
 - › Login with your FSU email address and password

STEP 2: ONLINE FORMS (COMPLETED BY STUDENT)

- Health History Form
- TB Screening Questionnaire
 - › Depending on your risk factors, additional information and/or a TB test performed within the last 6 months may be required

STEP 3: IMMUNIZATIONS

- Obtain a copy of your immunization records signed by your health care provider with your name and date of birth on each page
- Manually enter vaccine dates or lab titer results in Month/Day/Year format
- Some vaccinations may already be imported to your file from the Massachusetts Immunization System; you do not need to re-enter vaccines that already appear in your record

STEP 4: UPLOADS

- Upload your immunization record*
- Upload other documents if applicable: TB Health Care Provider form, TB test results, titer lab reports
- ATHLETES and POTENTIAL ATHLETES ONLY: Upload a physical exam performed in the past 18 months*

*You may submit the FSU Immunization Record, the FSU Physical Exam Form (athletes only) OR a similar document that contains your name and date of birth on each page and is signed by a health care provider (FSU forms located in Student Health Portal)

Be sure you have **ENTERED THE DATES OF EACH VACCINE** and **UPLOAD A COPY OF THE VACCINE RECORD**
Both steps are required to be cleared

VERIFICATION PROCESS

- Please allow 5 business days for your records to be reviewed and verified
- We will reach out via email if any requirements are incomplete

REQUIRED IMMUNIZATIONS AND TB SCREENING

Please note the following:

- Each page of the vaccination record must include the students name and date of birth.
- Screen shots are not acceptable. Please download and print the FSU Immunization Record for your health care provider to complete, or obtain your official immunization record from your health care provider or patient portal.
- The official laboratory report must be submitted if you are providing laboratory evidence of immunity (titer).

VACCINE	REQUIREMENT
Tetanus-Diphtheria-Pertussis (Tdap)	1 dose of Tdap within the past 10 years.
Hepatitis B	3 doses of Engerix-B or Recombivax-HB; OR two doses of Heplisav-B given at age 18+; OR laboratory evidence of a positive Hepatitis B surface antibody titer (anti-HBs).
Measles, Mumps, Rubella (MMR)	2 doses; first dose must be given on or after the 1st birthday, and second dose must be given \geq 28 days after first dose; OR laboratory evidence of immunity (MMR IgG titers)- if not immune to all three parts of the vaccine, you will need to complete the combined vaccination series; OR birth in the U.S. before 1957 acceptable only for non-health science students (history of disease not acceptable).
Varicella (Chicken Pox)	2 doses; first dose must be given on or after the 1st birthday and second dose must be given \geq 28 days after the first dose; OR documented history of varicella disease including date and health care provider endorsement; OR laboratory evidence of immunity (Varicella IgG titer); OR birth in the U.S. before 1980 (acceptable only for non-health science students).
Meningococcal ACWY	1 dose MenACWY (formerly MCV4) required for students 21 years of age or younger AND for all campus resident students, regardless of age. <u>The vaccine must have been given on or after your 16th birthday;</u> doses received at younger ages do not count towards this requirement. Meningococcal conjugate vaccine, MenACWY (MCV4) and MenABCWY, fulfill this requirement; monovalent meningococcal B (MenB) vaccine is not required and does not meet this requirement. Students may decline MenACWY vaccine after they have read and signed MDPH Meningococcal Information and Waiver Form (found under "uploads" in the student health portal).
Tuberculosis (TB) Screening	Complete the Tuberculosis (TB) Screening Questionnaire (found under "Forms" in the student health portal). A TB test and/or other documentation is required if you have certain risk factors; you will be notified if further information is needed after completing the TB Screening Questionnaire online. If a TB test is needed, it should be performed no earlier than 6 months prior to semester start. Upload official lab results and ask your health care provider to complete the TB Health Care Provider form located under "forms" in the student health portal.
